Health Research Paper - 92% of the students enrolled score at or above the benchmark during the fall of 2019. Due to COVID-19 and the change in delivery format this assignment was not completed in the spring.

• Beginning Fall 2020 – the HHP 351 assignment will be removed from SLO # 1

HLTH 475 was impacted by Covid 19. We were unable to visit the schools for the field experience. Students submitted a virtual field experience using Canvas Studio. One student did not complete the assignment.

We now rely on staff in the Educator Preparation Program office to provide PRAXIS score data. The data is provided in an aggregate format which resulted in a change in the way we are reporting results.

Health PRAXIS 5551- The benchmark was not met. 76% of the students passed the Health Praxis 5551.

HOW HAS THE DATA BEEN USED TO IMPLEMENT A CHANGE OR TO INFORM A DECISION?

It has been determined that HHP 351: Substance Abuse Prevention will no longer be used to collect SLO data.

I am hoping that we will be able to visit the schools in spring 2021. This was a real challenge to get our students to teach virtually on such short notice.

As a result of candidates not meeting the PRAXIS Benchmark, a new course, HPED 280 PRAXIS Seminar, has been developed. HPED 280 PRAXIS Seminar (1 credit hour) will prepare HHP K-12 candidates for the ETS Physical Education Content and Design PRAXIS exam. This seminar will provide a PRAXIS overview, review course content knowledge and skills, and develop candidate test taking strategies.
