#### I-69

- From Fulton, Kentucky, I-69 is planned to continue to the southwest, replacing and bypassing existing U.S. Route 51, serving Union City, Dyersburg (where it will intersect Interstate 155), Ripley, Covington, Millington, and Memphis.

Deferral of capital gains that would otherwise be due on the sale of appreciated stock. The deferral reduces the net present value of the investor's capital gains tax liability.


A future reduction of 10 to 15 percent of the capital gains tax liability if the investment is held by the taxpayer for five to seven years.


